OFFICIAL RULES – SAL’S PIZZA CEREMONIAL FIRST PITCH

Sal’s Pizza Ceremonial First Pitch Giveaway (the “Giveaway”) is sponsored by Sal’s Pizza, at 290 Merrimack Street, Lawrence, MA. Participation in the Giveaway constitutes the entrant’s (“you” or “your”) full and unconditional agreement and acceptance of these Official Rules including the decisions of the Sponsor, which are final on all matters relating to the Giveaway. The Sweepstakes is open only to legal residents of Massachusetts (the “**Eligible Territory**”) over the age of 18 to nominate a child who is their student or child/legal ward in grades 3-6 for the 2022-2023 school year, and currently enrolled in the Boston Public School System at the time of entry. 1. Basic Information: A student in grades 3-6 can be entered in the giveaway by a parent, guardian, or teacher as described below. This student must demonstrate leadership within their school, community or within their own family and shows proven academic potential. The winner must be able to attend the Boston Red Sox game on Thursday, June 29th with the Child (and, if entry was submitted by a teacher, Child's parent/legal guardian). Any questions, concerns or comments regarding the Giveaway can be forwarded in a self-addressed, stamped envelope to "Sal's Pizza Red Sox Ceremonial First Pitch, Sal's Pizza, 290 Merrimack Street, Lawrence, MA 01843".

2. Giveaway Dates: The Giveaway begins at 12:00:01 PM Eastern Time ("EST") on May 30, 2023 (the Start Date) and ends at 12:00:00 AM EST on June 19, 2023 (the End Date). The period from the Giveaway Start Date through to the First Pitch End Date is known as the "Giveaway Period". All eligible entries received between this period will be entered for the chance to win the prize.

3. Who Can Enter: The Sweepstakes is open only to legal residents of Massachusetts, who are eighteen (18) years of age or older and a parent/legal guardian or teacher of a student in grades 3-6 in the Boston Public School Systems ("Child"). Employees, officers, and directors, and their immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and members of the same household (whether or not related), of Sal's Pizza ("**Sponsor**"), the MLB Entities and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any other entity associated with the Sweepstakes are not eligible to participate or win a prize. 5. Judging: Students will be judged by a panel of judges at Sal's Pizza. Students will be judged on how well they have demonstrated proven academic potential and how well they have demonstrated leadership within their school, community or their own family. Sal's Pizza reserves the right to choose the winner based on this criteria, as provided in the nomination provided. In the event the winner cannot attend the game, an alternate winner will be chosen.

5. Prize Details: There will be one (1) Winner chosen on June 19th, 2023, to award four (4) Red Sox tickets for winner, Child, and three (3) guests (one of whom must be the Child's parent/legal guardian if the Child was nominated by a teacher). This

Giveaway prize includes the opportunity to throw the ceremonial first pitch at the Boston Red Sox home game on June 29th, 2023, four (4) tickets for winner, Child, and two (2) guests (one of whom must be the Child's parent/legal guardian if the Child was nominated by a teacher), transportation to and from Fenway Park via car service from home in Boston, and 25 Sal's Pizza "Free Slice" cards. Exact nature and duration of the ceremonial first pitch shall be determined in the sole discretion of Sponsor and the Boston Red Sox and subject to availability. Use of any Major League Baseball game/event/exhibition ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket; see redsox.com/ticket back for details. Seat locations at the game/event/exhibition and, unless otherwise stated in the prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. Winner's guest(s) must be of legal age of majority in his/her(their) jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game/event/exhibition, as defined by Major League Baseball, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Winner and his/her guest(s) agree to comply with all applicable ballpark and venue regulations in connection with the prize; see redsox.com/ballpark for details. Sponsor and the MLB Entities reserve the right to remove or to deny entry to the winner and/or his/her guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at the game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture and may invalidate the license granted by the game/event/exhibition ticket.
